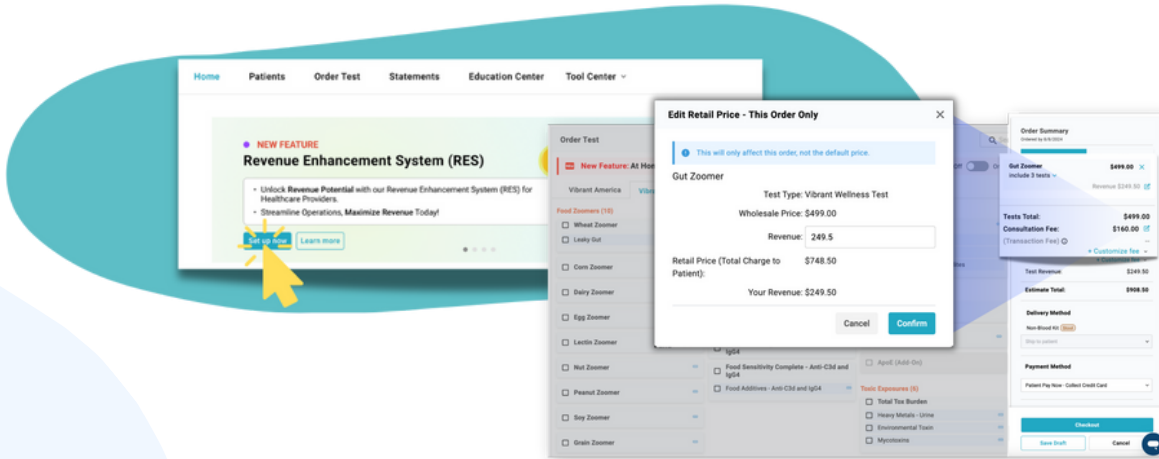

By Percentage

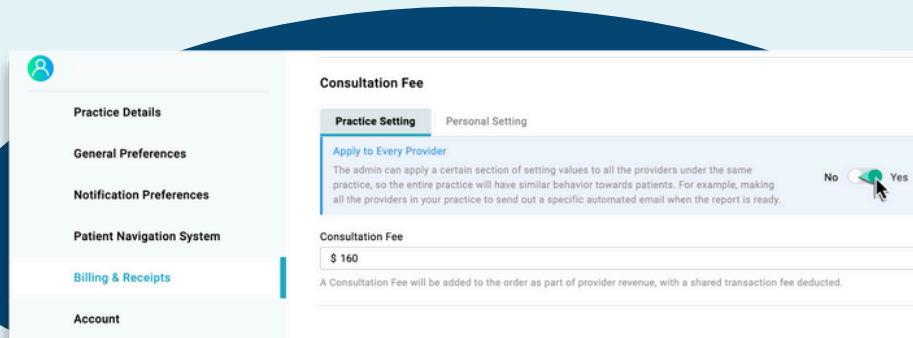
