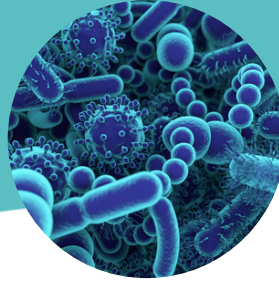

Who Will Benefit from Food Sensitivity Testing?

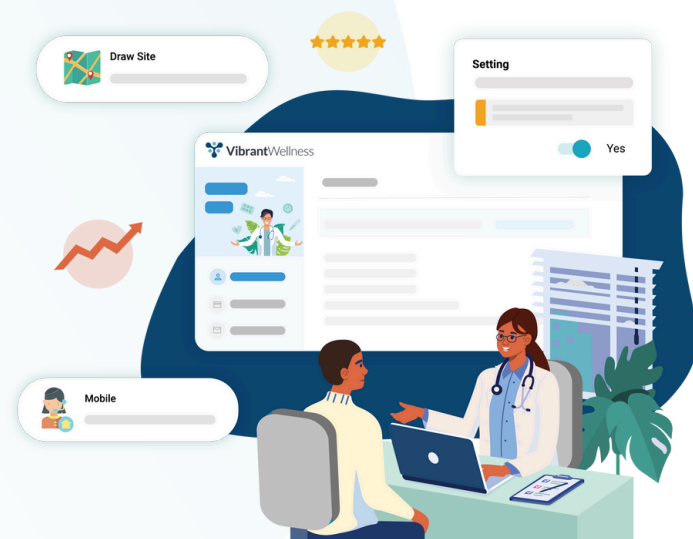
