Who Will Benefit from the Heavy Metals Test?

Additionally, professions and hobbies associated with an elevated risk of heavy metal toxicity include fuel, munitions, painting, rubber manufacturing, industrial smelting, mining, photographic processing, agriculture, working with semiconductors, welding, working in or near airports, and working in waste or radioactive waste disposal sites.

 - Nausea, vomiting, diarrhea, abdominal pain, nutrient malabsorption (particularly minerals), dry mouth, metallic tastes, pancreatic cancer
- · Skeletal and bone-related symptoms
 - o Osteoporosis, reduced bone mineral density
- Dermatological symptoms
 - Dermatitis, eczema, dry skin, sweating, skin lesions, hyperpigmentation, hair loss, allergic skin reactions
- · Renal and hepatic symptoms
 - Renal failure, elevated liver enzymes, hepatic damage, hepatic failure, suppressed hepatic detoxification, elevated hepatic enzymes

 - o Infertility, difficulty conceiving, birth defects, miscarriage

What to Expect from the Test


- 1. Follow our simple instructions to perform this test at home (via urine collection) or at a practitioner's office (via urine or blood collection).
