#### INTRODUCTION

Chickpea is a type of legume that helps to increase satiety, boost digestion, and keep blood sugar levels stable. To reduce the level of lectins in chickpeas, it is recommended to soak overnight, rinse and drain, then thoroughly cook or use a pressure cooker. Taking digestive enzyme supplements can help in digesting legumes.

Kidney beans are low in fat and rich in complex carbohydrates, minerals, proteins, and vitamins. Its nutrition has been linked to reduced risk of various cancers, heart disease, and diabetes. However, raw red kidney beans contain high levels of a lectin called phytohaemagglutinin (PHA) in the seeds. As few as four or five raw beans can trigger symptoms (e.g., vomiting, diarrhea, abdominal pain) within 1 to 3 hours of ingestion.<sup>22</sup> A hemagglutinating unit (hau) is a measure of lectin content. In their raw form, red kidney beans contain 20,000–70,000 hau. Once they're thoroughly cooked, they contain only 200–400 hau, which is considered a safe level.

Barley is an excellent source of both soluble and insoluble fiber. Barley has been shown to improve skin care, boosting immunity, and preventing disorders such as osteoporosis, gallstones, and diabetes.<sup>7</sup> To lower the level of lectins in barley, it is recommended to soak and sprout hulled uncooked barley grains or buy sprouted barley flour for baking. Raw barley grains can be sprouted by soaking them for 8-12 hours and then sprouting them over the course of about 3 days. Using a pressure cooker does not deactivate lectins in barley.
